# CITY OF ST JOHN POLICE DEPARTMENT RULES AT THE FIRING RANGE

1. USE OF THE RANGE WILL BE (8 AM TO 8 PM IN SUMMER) AND (8 AM TO 5 PM IN THE WINTER).
2. RANGE WILL BE CLOSED TO PUBLIC ON DAYS POLICE OFFICERS ARE QUALIFYING.
3. ALL FIRE WILL CEASE ONCE AN OFFICER ARRIVES AT THE RANGE IN ORDER FOR CONTACT TO BE MADE AND PERMIT TO BE CHECKED.
4. PERMITS REQUIRED.
5. PERMIT HOLDERS UNDER 18 YEARS OF AGE MUST HAVE PARENT, GUARDIAN, HUNTER SAFETY INSTRUCTOR OR LAW ENFORCEMENT PRESENT THAT HOLDS A PERMIT ALSO.
6. CONTACT WITH DISPATCH IS REQUIRED AND CHECK IN SHEET IS TO BE SIGNED EACH TIME PERMIT HOLDER IS USING THE RANGE.
7. FLAG MUST BE RAISED ON FLAG POLE WHILE FIRING. FLAG IS LOCATED IN PVC PIPE FASTENED TO THE FLAG POLE.
8. RIFLES ON THE NORTH (GRASS) SIDE OF THE RANGE.  
PISTOLS ON THE SOUTH (ASPHALT) SIDE OF THE RANGE.  
BOW & ARROWS ON THE NORTH (GRASS & HAY BAIL) SIDE OF THE RANGE.
9. NO ALCOHOL OF ANY KIND ON THE PROPERTY.
10. NO GLASS, CANS, WOOD, METAL, ETC TARGETS. PAPER TARGETS ONLY.
11. SAFETY GLASSES AND EAR PROTECTION WORN AT ALL TIMES DURING FIRE.
12. NO ONE DOWN RANGE DURING FIRE.
13. WEAPONS POINTED DOWN RANGE ONLY.
14. NO UNSAFE MANUFACTURED WEAPONS OR UNSAFE POWDERED AMMO.
15. ALL BRASS AND TARGETS WILL BE PICKED UP AT THE END OF FIRING.
16. NO DRIVING INSIDE THE FENCED AREA OF THE RANGE.
